



MATHNASIUM TEACHERS WHO COUNT SWEEPSTAKES RULES 2026

Sweepstakes Sponsor: Mathnasium Franchisor LLC (“Mathnasium”) (referred to herein as the “Sponsor”) is the sponsor of the Mathnasium x Teachers Who Count Sweepstakes 2026 (this “Sweepstakes”) described in these official sweepstakes rules (“Sweepstakes Rules”).

Eligibility: This Sweepstakes is open only to individuals (“Entrants” or “you”) who are legal residents of one of the fifty (50) states or the District of Columbia of the United States. Entrants must be 18 years of age or older.

Directors, officers, and employees of Mathnasium and Baked by Melissa and any of its subsidiary companies, or their respective professional advisors, advertising and promotional agencies, and prize suppliers, and immediate family members of any of them, are not eligible to participate. “Immediate family members” include spouses, siblings, parents, legal guardians, children, grandparents, and grandchildren, whether as “in-laws,” or by current or past marriage, remarriage, adoption, co-habitation or other familial extension, and any other persons residing at the same household location, whether or not they are related.

Sweepstakes Period: Entries will be accepted online starting on August 17th, 2026, at 12:00 am Pacific Time (“PT”) and shall end on September 18, 2026, at 11:59 pm PT (“Sweepstakes Period”).

How to Enter: Eligible entrants can enter the Sweepstakes by visiting [Teachers Who Count Sweepstakes](#) and following the instructions to complete and submit the entry form. You must provide all information requested. Incomplete or non-compliant entries will be disqualified at Sponsor’s sole discretion. Each email address may have up to two entries: (1) the first entry must be submitted as described above, and (2) a bonus entry may be submitted on the official “reminder to enter” post on the Mathnasium Instagram account to be posted on August 20, 2026. Use of any automated system or agent to submit entries is prohibited and will result in disqualification. All entries become the property of the Sponsors. In order to be named an official winner, participants must abide by these Sweepstakes Rules.

Prize Winner Notification and Requirements: Potential winners will be notified via email within seven (7) days of the end of each Sweepstakes Period, with instructions on claiming the Prize.
